### **TITLE: Capital Virement Vehicle Purchases**

#### **EXECUTIVE SUMMARY:**

As a result of the withdrawal from the PFI contract with Venson in December 2020, the force will directly incur the cost of purchasing all vehicles. During the exit process it was identified that £283k worth of costs were incurred in relation to new vehicles under the Venson replacement programme, this cost can no longer be recharged to Venson. Whilst existing budgets have been used to off-set the costs, it has created the need for virements within the fleet projects to cover the costs.

It is requested to vire £227k into the vehicle and equipment replacement capital programme, £56k of costs can already be met from that project.
