TITLE: Programme Management of Regain

EXECUTIVE SUMMARY:

Transactional elements relating to finance, payroll, L&D and people services for the force have historically been carried out by the Multi Force Shared Services (MFSS). These arrangements are due to come to an end in November 2022.

Project Regain has been set up to manage the transition from MFSS to alternative provision. As the programme is highly complex and involves a number of stakeholders and suppliers and as such the delivery of the programme has extended.

Pracedo Business Solutions have been engaged to deliver this project since its inception and as such it is uneconomical to replace. There are now firm plans in place and contracts with suppliers to deliver the programme by April 2022.

The intention is to continue the arrangement with Pracedo Business Solutions (under new contract terms and conditions) from 1st April 2021 to 30th June 2022, allowing the programme to be properly concluded.

INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

This contract is being awarded to the supplier directly for business continuity and efficiency reasons as it would be uneconomical to introduce a new project manager at this stage of the programme.

The previous arrangement with Pracedo was based on a day rate of £695 per day. The new arrangement continues with this rate and assumes 20 working days per month until the end of June 2022.
