TITLE: New Adult Sexual Assault Referral Centre (ASARC)

EXECUTIVE SUMMARY:

By the Decision Notice dated 20th May, 2020, it was agreed to fund the estimated cost of £1.6m (circa £1.3m new spend) to design and build a new adult SARC building and include that sum in the capital programme.

Since that time, a Design Team has been appointed, a full design has been completed, full planning permission has been obtained and the construction works have been competitively tendered.

Five contractors submitted tenders for the construction with tenders being returned by 5th March, 2021. Unfortunately, the lowest tender was approximately £510,000 above the approved budget. In consultation with and on the advice of MINT Commercial Services, the two lowest tenderers were invited to participate in a value engineering exercise to seek to reduce the cost of the project.

The value engineering exercise has resulted in savings of approximately £168,000, which has reduced the additional budget requirement to £342,000.

The majority of the additional costs are relating to the mechanical and electrical aspects of the project. Whilst significant savings have already been made in this area, work will continue to seek further ways to reduce these costs as the project progresses, but authority is now sought to proceed with the project at the revised cost.

Following the competitive tender process and value engineering exercise, the capital cost of designing and constructing the new SARC building is now estimated to be in the region of £1,942,000. Taking into account a contribution from NHS England, the net capital cost to the Police is estimated at circa £1,642,000. This will require an additional capital provision of £342,000 from the PCC Reserve.
