#### **EXECUTIVE SUMMARY:**

To seek approval for spending of £3892 + VAT from the Late Night Levy monies to enable a CCTV camera to be pole mounted to an existing lighting column outside McDonalds on Milton Street, Nottingham City Centre.

## INFORMATION IN SUPPORT OF DECISION: (e.g report or business case)

Milton Street is a hotspot for ASB and in the last 2 years has been a location where a number of serious violent incidents have occurred including 2 murders and a serious stabbing, leading to wider tensions across the city.

There is currently no CCTV coverage at the proposed site leaving it vulnerable to further crime and ASB. The provision of CCTV will provide vital evidence / information for the police both to prevent and detect crime. It will also provide reassurance for local businesses and the community, as well as deterring potential offenders from committing crime and ASB in the City Centre.
