## EXECUTIVE SUMMARY:

### This notice is for the Direct Award to Virgin Media Business UK

Virgin Media Business are the incumbent provider for the Nottinghamshire Police Force's Wide Area Network Connectivity services.

This notice is requesting approval for the direct award to Virgin Media Business UK for a 5 year Wide Area Network Connectivity contract with a total value of £1,637,953.65.

## INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The route to market for the Wide Area Network service from Virgin Media Business UK was via Crown Commercial Services (CCS) Framework RM3808 Lot 1.

The decision to direct award was taken due to strong previous supplier performance, agreed discounts resulting in improved value for money versus the previous contract, the impact of the cost to change within the Force and as there was a compliant route to market available via the above framework.

This is a 5 year contract valid from 12<sup>th</sup> May 2021 to 11<sup>th</sup> May 2026 with no option to extend.


## FINANCIAL INFORMATION

The total contract value is £1,637,953.65, which equates to £327,590.73 p.a.


Based on the previous contracted spend of £350,748.32 p.a. this represents a reduction of £23,157.59 p.a. which is a total saving of £115,787.95 over the 5 year contract.


This also represents a total saving versus the agreed budget of £405,646.35.
