EXECUTIVE SUMMARY:

The above premises which comprise offices and storage facilities are occupied by Nottinghamshire Police under a 10 year lease which expired on 4 October, 2019.

Since that time extensive discussions have taken place regarding a further long term lease. However, the site was formerly a gas depot and the landlord, National Grid Property Holdings/Birch Sites, is keen to complete site investigation works to establish the extent of any underground contamination prior to arranging clean up works and before a further long term lease is entered into.

Therefore a two stage approach has been agreed with a short term lease being entered into, backdated to the expiry of the previous lease. This short term lease will run until 30 September, 2021 following the completion of site investigation works. This will be followed by a further 10 year lease upon expiry of the short term lease, with a tenant only break option after 5 years.

As part of the negotiations, a substantial reduction in rent has been negotiated to take effect from 5 April, 2020. The confidential Heads of Terms documents for both the short term and long term leases are attached as appendices.




