**EXECUTIVE SUMMARY:**

Ministry of Justice (MoJ) has awarded Commissioner Henry new Covid Recovery funding for domestic and sexual violence support services in 2021-2, plus additional funding for specialist Independent Sexual Violence Adviser (ISVA) and Independent Domestic Violence Adviser (IDVA) posts to help reduce waiting lists. The funding awarded is as follows:

The funding has been awarded to help domestic and sexual violence support services cope with additional demand as Covid restrictions are eased and more survivors come forward for help. IDVA and ISVA funding was awarded to ensure that ISVA and IDVA services are supported to tackle waiting lists and maintain appropriate caseloads.

Commissioner Henry is requested to approve the following funding awards:

**1. To be paid for by MoJ Domestic Abuse Uplift Grant 2021-2:**

- Up to £29,443 to Equation to pay for county wide targeted domestic abuse awareness raising campaigns and greater specialist resources including Help a Friend;
- Up to £60,000 to Juno Women's Aid to contribute towards the cost of family court support in city and county south;
- Up to £30,000 to Notts Women's Aid to contribute towards the cost of family court support in county north;
- Up to £10,000 to Broxtowe Women's Project to pay for additional capacity in Broxtowe based domestic abuse support;
- Up to £14,000 to NIDAS to contribute towards teen outreach and support work in Ashfield and Mansfield;

- Up to £22,000 to Nottingham Muslim Women's Network to work with Juno Women's Aid to provide dedicated support for Muslim women;
- Up to £12,000 to We R Here to pay for specialist counselling for domestic abuse survivors, including adults and children
- Up to £12,000 to Nottingham Women's Centre to pay for specialist counselling for adult domestic abuse survivors;
- Up to £6,912 to Mojatu to pay for support for FGM and domestic abuse survivors.

### 2. To be paid for by Sexual Violence Uplift Grant 2021-2:

- Up to £87,661 to Imara CIO to pay for additional specialist therapy for children and young people who have experienced sexual violence and abuse, a Family Support Worker and the development of increased resources;
- Up to £44,272 to Notts SVS Services to pay for additional ISVA and counselling capacity within commissioned sexual violence support services
- Up to £7,500 to SHE UK to contribute towards peer support for sexual violence survivors.

- Up to £88,626 to Notts SVS Services to pay for additional counselling support

All funding is awarded subject to providers meeting funding criteria.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

MoJ allocated the Nottinghamshire PCC additional £424k SV and DV Uplift Funding to support Covid recovery in specialist domestic abuse and sexual violence support services in 2021-2. MOJ guidance stipulated that PCCs must undertake an open and transparent assessment of need in relation to both SV and DA support services in their local area. PCCs were not required to undertake a full competitive bid process.

In addition to this funding, all PCCs were able to bid into an Independent Domestic Abuse Adviser/Independent Sexual Violence Adviser (IDVA/ISVA) fund via an Expression of Interest. The fund was to focus predominantly on increasing the number of ISVAs and IDVAs across local areas to expand service capacity in response to the pandemic.

In response to MoJ's funding requirements the NOPCC:

- produced an Expression of Interest (EoI) form based on the DA/SV Uplift Funding MOJ needs assessment template
- produced and published local Guidance Notes for all potential applicants which stated all EoIs would be assessed against stated MoJ criteria plus some additional local criteria on required quality standards and partnership working
- publicised the funding opportunity in mid February, contacting all 16 of the local DSVA services which secured MoJ Covid funding in 2020-1 and also publicising the opportunity through a local DSVA professionals network which goes to over 1,400 individuals. There was also a press release and information on the PCC's website and social media accounts.
- used all completed EoIs at the end of February to inform the PCC's own EoI to the national IDVA/ISVA fund, which had to be submitted by 3 March 2021.

The OPCC received 25 EoIs. They were assessed against the published criteria and RAG rated by a panel including two OPCC staff plus the strategic domestic abuse and sexual violence leads from Nottinghamshire County Council and Nottingham City Council. The only requests received for additional IDVA and ISVA funding came from the co-commissioned support services. Therefore these were used to inform the final EoI for additional IDVA/ISVA funding which was submitted to MoJ in March. The EoI was also informed by the monthly referral and waiting list updates and the regularly Operational Pressures Escalation Levels reporting that the OPCC receives, which clearly demonstrated that additional staff were required to meet demand.

MoJ has awarded Commissioner Henry all the IDVA and ISVA funding requested and stated that the funding is to reduce waiting lists and maintain manageable caseloads.

The funding will be managed as follows:

Domestic abuse funding will be awarded through the existing PCC/local authority co-commissioned domestic abuse support contracts, which are led by Nottingham City and Nottinghamshire County Councils. This will be done under the terms of local authority/PCC partnership agreements. Nottinghamshire County Council has confirmed that it will call off the support under its existing domestic abuse framework. Nottingham City Council will confirm its approach in early June.

The PCC will award the ISVA and CHISVA funding to the commissioned ISVA and CHISVA providers. This may be done lawfully because:

- the PCC published the funding opportunity as set out above;
- EoIs from 25 organisations were assessed;
- the Covid-19 pandemic was not foreseeable;
- the PCC needs to respond immediately to the consequences of the Covid-19 pandemic on the services. The PCC has received clear evidence of waiting lists rising, both because of the impact of the Covid-19 pandemic on survivors and due to the worsening of delays in the court system due to the Covid-19 pandemic; and
- running a procurement process for the provision of additional ISVAs would create further delay in support for vulnerable people that need those services immediately and any further delay could impact their health.

Other funding awards will be managed in compliance with Commissioner Henry's Financial Regulations.

### FINANCIAL INFORMATION

The funding has been confirmed in writing to Commissioner Henry by MoJ and is in budget. 2022-3 funding has been awarded as an indicative allocation, consequently whilst where appropriate contracts will be awarded for 2021-2 and 2022-3, 2022-3 funding will be subject to further confirmation of funding from MoJ.
