### EXECUTIVE SUMMARY:

Proposals have been advanced to relocate Newark Police Station from its current location to a joint 'hub' with Newark and Sherwood District Council. The Police and Crime Panel was notified of this proposal in March 2021 as a 'decision of significant interest'.

The incumbent Police and Crime Commissioner took office formally on 13th May 2021 having made a campaign commitment to ensure that a full public consultation on the proposed relocation has been carried out.

There is therefore a need to commission a robust public survey to ensure that this commitment can be implemented and that meaningful public consultation informs any decision on the future of Newark Police Station.

This need is consonant with the Commissioner's responsibility to listen to and reflect the thoughts and feelings of the residents of Nottinghamshire.


A proposal has been received that will discharge this requirement in a timely and cost effective manner.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The Commissioner is charged with seeking the views of Nottinghamshire residents, this expenditure is in direct support of that charge and represents an important contribution to the effort to seek the views of the public in Newark with regards to their local police station.

A strong and defensible methodology has been sought to undertake this work to ensure a representative sample of opinion, ensure rigour of analysis and to protect the data of participants.


