| EXECUTIVE SUMMARY: |
| <p>In preparation for a bid submission to the Home Office Safer Streets (Round 3) fund to improve safety and feelings of safety for women and girls, a Focus Group was undertaken by the Nottingham Women's Centre on behalf of the PCC with a small group of women and insight was obtained to help shape an online questionnaire. To compensate participants, vouchers were purchased and awarded to the total value of £83.00.</p> |



| <p>Advice received from staff working at Nottingham Women's Centre indicated that a low value £10 voucher would encourage increased take up and committed time by key participants. The feedback and insight was received at no cost to the PCC and will be invaluable in shaping the questions for the online survey to help better understand factors associated with higher levels of safety or otherwise.</p> <p>The PCC is able to submit 3 bids each up to £550k and so this small cost is seen as an invest to save. The findings of the focus group will help strengthen the quality of the bids.</p> |
