#### **EXECUTIVE SUMMARY:**

The stock condition surveys have been conducted and identified £10m of back log maintenance to be done over the next 5 years. Gleed's have been appointed to carry out the first phase to implement the priority 1 and 2's. The Phase 3 has been traditionally procured which covers sites Bulwell and Ollerton plus various joinery items.

This requirement is for PHASE 4 and we will require appointment of a consultant and contractor

The following site has been identified to be done under Phase 4 in financial year 21/22

Oxclose Lane – roof replacement and window overhaul/replacement

The Estates Team have an established working relationship with Lindum and provided the most competitive costs at £1,042,254.51 within the Pagabo framework which is why the decision was taken to direct award to Lindum, therefore the intention is to direct award to Lindum Group Ltd via the Pagabo Framework to enable a quicker route to market and engage with the principal contract at an early stage. The Framework allows contracting authorities to make direct awards under Lot 2 subject to certain parameters which have been adhered to. Given that a large portion of the works will be to the external envelope it would be necessary to conduct works during the summer months into early autumn.

Therefore the approval to make a direct award to Lindum under the Pagabo framework to the value of £1,042,254.51 is being requested.
