## EXECUTIVE SUMMARY:

In March 2021 the Commissioner announced an award of up to £25,000 for a Stapleford Place Fund (see dec notice 2021.022). The focus for this fund was to be on the area surrounding Hickings Lane playing field and on improvements that could be made to this area to ensure people living in the area felt safe and secure. Key partners and stakeholders have now come together, reviewed the area and devised a spend plan to improve security in the area.

## INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

Following the announcement of the Stapleford Place Fun in March 2021, an initial assessment of the Hickings Lane area was undertaken by the Design Out Crime Officer from Nottinghamshire Police. This was then presented to a meeting of the Stapleford Focus Group on Wednesday 14<sup>th</sup> April 2021. An action was taken at that meeting for a further site visit to take place with input from officers at Broxtowe Borough Council who are responsible for the CCTV/lighting/parks management and the local Police Constable and Police Sergeant. This site visit took place on 23<sup>rd</sup> April 2021 from which a report was put together that detailed the key observations from the visit; a series of proposals to improve the area and an outline of the financial implications associated with the proposals.


The main proposals and financial implications are detailed below:

1. Supply and install 2 new replacement 360° infra-red cameras on the existing poles and supply and install 1 new camera at Wesley Place, this includes 2 year warranty and air time **£14,200**.
2. Supply and install new flood lights to existing columns to illuminate the play area and new lighting columns and flood lights to illuminate Wesley Place the bowling green and the rear of the play area **£7,000**.
3. Supply and install fencing and gate at West Cross Avenue entrance **£2,500**.
4. Repairs to fence on boundary with Scout Hut **£500**.
5. Contingencies **£800**


The work would be carried out by Broxtowe Borough Council.


