## EXECUTIVE SUMMARY:

The PCC plans to commission Leaders Unlocked to deliver targeted engagement with young people and under-represented groups across Nottinghamshire throughout 2021/22. 20-25 young people aged 14 to 25 will be recruited and trained to join the Youth Commission. The Youth Commission will engage young people from diverse backgrounds including harder-to-reach groups such as ex-offenders.

## INFORMATION IN SUPPORT OF DECISION: (eg report or business case)


Having successfully delivered a range of projects since 2016/17 and embedded their delivery model among local youth leaders, the PCC will issue a further grant to Leaders Unlocked for the 2021/22 period (July 2021 to June 2022) in order to enable immediate consultation and engagement activity to take place to support development of the Commissioner's 2021 to 2024 Police and Crime Plan. The funding will also provide stability to the project during the PCC transition year with a view to undertaking a competitive tendering process for the project in 2022. The PCC recognises the additional value offered via the Leaders Unlocked national infrastructure which has led to sharing of ideas and good practice among other national Youth Commissions and the involvement of Nottinghamshire members in relevant national programmes of activity.

## FINANCIAL INFORMATION

£28,000 revenue funding split over two financial years as follows:


- July 2021 to March 2022- £21,000
- April 2022 to June 2022 - £7,000


This is included within the Community Safety budget.
