EXECUTIVE SUMMARY:

This purpose of this report is to recommend and seek approval for the awarding, by way of a direct award, of a contract to The Adecco Group for the provision of a contingent labour managed service for administrative and specialist posts.

This contract will be for 7 years from 1st July 2022 to 30th June 2029.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

This is a re-procurement using the Bluelight Commercial (BLC) national framework for Contingent Labour Services (BLC0013). The BLC procurement was subject to extensive market and stakeholder engagement prior to the publication of the tender documentation with advice on the procurement process being sort as required from Capsticks Solicitors.

This contract will replace the existing Nottinghamshire contract with Brook Street.
