#### **EXECUTIVE SUMMARY:**

The capital budget for 2021/22 was £28,360k, the outturn at the end of the financial year was £18,811k resulting in an underspend of (£3,804k) and a slippage request of (£5,744k).

Slippage is requested where it has not been possible to complete a project in the financial year in which the budget was allocated.

Supply chain issues have played a major part in the slippage requests for all projects and a request to have slippage of (£5,744k) into 2022/23 is requested to support the continuation of projects through to completion.
