### EXECUTIVE SUMMARY:

This decision notice seeks approval of funds to be spent from the VRU budget for the following to be spent during 2022/23:

- Document design of the Serious Violence Strategic Needs Assessment (SNA), Response Strategy and Strategic Framework (£5850)
- Contribution of funds to the County Council's Youth Services team (£100,000)

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

#### Document design

The VRU are required to prepare and publish the following mandatory documents as outlined in the Home Office Grant Agreement: Serious Violence SNA and Response Strategy. A quote has been obtained for £5850. As part of the PCC, a public sector organisation, this documentation must meet accessibility standards, which this will provide.

#### Nottinghamshire County Council (NCC) Youth Services


NCC Youth Services currently employ a dedicated team of 3.0FTE Youth Workers who deliver detached youth outreach focussed in hotspot areas of Nottinghamshire, linked to the Youth Justice Services prevention offer.

The offer seeks to engage children and young people on the periphery of offending with a view to providing a positive adult relationship and engagement in diversionary activities, as well as referrals to specialist services, including mental health and substance misuse provision.


A recent Nottingham Trent University evaluation has indicated that the team provide a highly effective service.


Given the common outcomes which both the Youth Services Team and the VRU intend to impact upon, the VRU wish to contribute £100,000 to support the continuation of this service during 2022/23.
