EXECUTIVE SUMMARY:

In March 2022 the Ministry of Justice (MoJ) announced additional funding for Domestic and Sexual Violence Support Services. Up to £15.7m was being made available specifically for domestic abuse and sexual violence support services and up to £7.2m for 200 additional ISVA and IDVA posts nationwide in 22/23. MoJ have committed that the funding will be delivered over a multi-year basis until March 2025.

Following receipt of Expressions of Interest from eligible local organisations and guidance from the MoJ, the PCC has been awarded a total of £1,702,947.83 to cover the period 2022/23 to 2024/25. This is broken down as follows:

- £402,178.61 pa for 2022/23, 2023/24 and 2024/25 for DA/SV victim support services; and
- £138,070 for 2022/23 and £179,171 for 2023/24 and 2024/25 for 3.8 FTE IDVA posts.

In addition, the PCC has also been awarded a further uplift from the MoJ in relation to the local commissioning sexual violence test framework. This uplift amounts to £76,533 pa for 2022/23, 2023/24 and 2024/25.

Commissioner Henry is therefore requested to approve the following funding awards based on receipt of the additional MoJ funding as detailed above and additional PCC core spend from the Community Safety Grant:

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

In order to inform the funding allocation, PCCs were asked to complete a new needs assessment based on information provided by local support services to enable a more up to date picture of local need.

The Nottinghamshire PCC asked for Expressions of Interest from eligible organisations. The funding opportunity was advertised on the PCCs website and the funding timetable was as directed by the MoJ. A number of applications were received which were all assessed by staff from the Office of the Police and Crime Commissioner, the City Council, the County Council and the PCC. The full Nottinghamshire assessment was then sent to the MOJ who, on 16 June 2022 confirmed Nottinghamshire's final funding allocation of £1,702,947.83 over the three financial years. The funding allocation was split into two distinct funding pots as follows:

- £402,178.61 pa for 2022/23, 2023/24 and 2024/25 for DA/SV victim support services; and
- £138,070 for 2022/23 and £179,171 for 2023/24 and 2024/25 for 3.8 FTE IDVA posts as directed by the MoJ.

The above funding was then combined with MoJ uplift funding for the local commissioning sexual violence test framework. Funding was then distributed to local organisations as detailed above.

Following legal advice, the majority of funding will be awarded to services via multi-year grant agreements. Where core commissioned DV services have received additional funding this will flow through the existing City and County Council commissioning arrangements.

FINANCIAL INFORMATION

This is a decision required for additional funding as granted to Nottinghamshire Police and Crime Commissioner by the MoJ as outlined above.

The decision also relates to additional PCC funding as detailed below which will come from the Community Safety Grant:

- 2022/23: £29,410.39 revenue funding
- 2023/24: £40,277.39 revenue funding
- 2024/25: £40,277.39 revenue funding
