EXECUTIVE SUMMARY:
<p>This proposal seeks an approval for the VRU to provide a one-month extension of funding counselling services provided by Al Hurrayah and Base 51 to support the safe exiting of participants from the intervention. The extension will take place from 1st September to 30st September 2022.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>Al Hurrayah and Base 51 currently have grants to deliver therapeutic counselling through their respective Growth and Evolution projects up until 31st March 2022 via the Community Safety and Violence Reduction Fund 2021-22. An additional 5 months of funding was agreed until the end of August to enable the completion of an open tender exercise, however the tender has been delayed due to the capacity of staff within the VRU and the Blue Light Commercial to facilitate it.</p> <p>This notice of decision seeks approval for a further £2,221.29 of funding between the aforementioned providers to continue this specialist work until such time that a full tender exercise is completed at the beginning of October 2022. Please note the tender exercise has started and is not expected to be delayed any further.</p>
