### EXECUTIVE SUMMARY:

The PCC works with Nottingham City Council to co-commission criminal justice substance misuse support services. Funding was previously agreed up until 31 March 2022.

The PCC and City Council will co-commission new services under the From Harm to Hope drugs strategy. In the meantime, support services need to continue to ensure no loss of service.

As previously agreed, the PCC is asked to provide confirmation of funding to Nottingham City Council from 1 April 2022 to 31 May 2023 for the following:

Adult substance misuse (Clean Slate) - £342,855.33 (£293,876.00 per annum)

Young people substance misuse- £32,998.00 (£28,284.00 per annum)

This is a total of £375,853.33 to be paid for out of Community Safety Grant.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

Continuation funding is required to ensure no loss of service provision. The City Council, as the lead commissioner, has sought professional advice for the contract extensions.

The PCC will award the funding to the City Council for the services, with the City Council then contracting with the providers.

The funding helps to meet the commitment in the Make Notts Safe Plan to fund criminal justice support services.
