EXECUTIVE SUMMARY:

Further to Decision Notice 2019.026 a further PCC contribution to the delivery of the Life Skills Primary Programme is being sought. The Commissioner is therefore requested to confirm her approval for a contribution of up to £40,000 to part fund the Life Skills Primary Programme being delivered in Schools during the 22/23 academic year (September 2022 and July 2023).

The funding would come from the 22/23 and 23/24 Community Safety Grant.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

Further to Decision Notice 2019.026 a further PCC contribution to the delivery of the Life Skills Primary Programme is being sought. This is to ensure that the programme can continue to be delivered in schools at a reduced cost.

A £40,000 contribution from the Commissioner for the 22/23 academic year would enable the Life Skills Primary Programme to be offered at 25% of the cost to state funded primary schools in Nottingham and Nottinghamshire. It is expected that approximately 5,376 pupils would benefit.

The aim of the programme is to build resilience in the young people who graduate from it, helping them to steer away from risky behaviours (including drugs and alcohol, knife crime and hate crime) and find the right support should they ever fall victim to crime.

FINANCIAL INFORMATION

The funding is revenue and is in budget. Funding will come from the 22/23 and 23/24 Community Safety Fund.
