EXECUTIVE SUMMARY:

The requirements for this project can be direct awarded on a public sector framework called Lexica – formally ETL which is a Lighting Framework implemented by other local authorities including councils and healthcare which Thorlux (the proposed supplier) are on and whom can be appointed through a direct award as main contractor by implementing the Framework Access Agreement.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

We are looking to replace the failing light fittings at St Ann's Police Station with a product that can provide a long warranty, longevity, smart monitoring and sustainability.

Smartsan provides wireless lighting control system which enables us to monitor energy performance and operational information for all fittings including emergency light fittings. The long terms vision is to standardise our estate so every building is on the monitored gateway, reducing costs for service maintenance. The smart system notifies us when a fitting is not operating, the system also self-tests emergency lighting on a monthly basis providing a report once completed.

Each Thorlux fitting operates independently, thus providing the maximum energy efficiency. They are also fully maintained lights, so should replacement parts be needed this can be done, the entire light does not need to be disposed of, and the internal components can be replaced. This reduces waste.

There are no other fittings with this technology, it's a unique true wireless system and there is no integration into our systems. Nothing other than GSM, stand alone system bouncing signal back to gateway.

The aftercare support level is local and responsive. We already have this system at Sherwood Lodge, Mansfield and part at Oxclose. Thorlux is the only manufacturer we have found who offers the police a 7-year warranty.

By doing a direct award we have the direct supply chain to F W Thorpe/Thorlux without having to go through an electrical contractor, who would then to go to a wholesaler etc who each would put their mark up on. This direct link provides better aftercare support and a more competitive price.
