| EXECUTIVE SUMMARY: |
| <p>The PCC is requested to confirm her approval for the following grant awards:</p> <ul style="list-style-type: none"> • Up to £114,511 to six local community organisations for the period Dec 2022 to March 2025 through the 2022/25 Make Notts Safe Hate Crime Thematic Grants. • Up to £98,790 to four local community organisations for the period Dec 2022 to March 2025 through the 2022/25 Make Notts Safe Communities Thematic Grants. <p>The above funding will come from the PCC core commissioning budget.</p> |

| INFORMATION IN SUPPORT OF DECISION: (eg report or business case) |
| <p>In January 2022 the PCC launched her new Make Notts Safe grants schemes. The Make Notts Safe Thematic grants provide multi-year funding for third sector community based organisations to enable local delivery against key priorities. Funding in relation to two themes – Hate Crime and Communities – opened in August 2022.</p> <p>The aim of the Hate Crime themed funding was to fund projects and initiatives that will help to prevent, identify and respond to hate crime in Nottinghamshire. The aim of the Communities themed funding was to fund projects and initiatives that will help to prevent, identify and respond to those issues which affect communities the most in Nottinghamshire.</p> <p>Applications were invited from community organisations with all applications undergoing a robust assessment process where applications were assessed by a minimum of two officers from the OPCC against a scored matrix. Applications were then discussed at an independent Stakeholder Panel which included senior police officers and representatives from the City and County Council. The panel agreed the final list of recommendations, which went to the PCC for approval.</p> <p>The PCC agreed the projects to be funded and provisional awards were made. Successful applicants were then invited to Stage Two of the process, which involved the development of the organisations’ theory of change and outputs and outcomes measurements. Following completion of this, final funding awards were confirmed.</p> <p>Six projects were successful in securing Hate Crime Thematic Grants and four projects were successful in securing Communities Thematic Grants. Brief details of the grant recipients are detailed below –</p> |
