### EXECUTIVE SUMMARY:

The current contract for the provision of Healthcare in Custody Services comes to an end at 31 May 2023, therefore a tender process has been conducted in order to give prospective suppliers the opportunity to bid for the new contract.

A decision is required to enter into a formal contract with Mitie Care and Custody Ltd. for the provision of Healthcare in Custody services. The contract period shall start on 1 June 2023 and end on 31 May 2030 with options to extend for up to a further 3 years.

### INFORMATION IN SUPPORT OF DECISION: (e.g., report or business case)

An open tender has been conducted in accordance with the Public Contracts Regulations 2015, advertised via Contracts Finder and Find a Tender. Proposals were evaluated on the basis of MEAT (Most Economically Advantageous Tender) 20% Price, 70% Quality, 10% Social Value.

A total of 4 tenders were received and evaluated.

The preferred bidder, following evaluation of tenders and scoring the highest overall, is Mitie Care and Custody Ltd.

### FINANCIAL INFORMATION

There is £1.1m budget available per annum for this service. The bid submitted by the preferred bidder is at an average annual contract price and is within this budget for the first two years. The contract price is fixed for two years, with appropriate caps on the negotiated price for years 3-7.
