EXECUTIVE SUMMARY:
<p>The Violence Reduction Partnership seek approval to utilise up to £1,500 during quarter 4 2022/23 and Q1 of 2023/24 for- the provision of therapeutic support to support the welfare of adult participants in community conversations (Decision notice 2023.010)</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>The proposal was supported by members of the Another Way Steering Group, pending formal approval by the PCC, CEO and CFO.</p> <p>As outlined in decision record 2023.010 a series of Community Conversations are being undertaken to inform participants about the 'Another Way' project and generate discussions (within the scope of the project) about ways to reduce harm and provide the best outcomes for young people involved. This will help to provide consistent insight to support the project design. It is envisaged that some of the participants may have lived experience of youth violence and its impact and these conversations may trigger re-victimisation.</p> <p>Al-Hurraya are currently commissioned by the PCC to provide therapeutic support to CYP who have experienced serious violence. Approval is required to vary this contract for a short period to include specific therapeutic support for any community conversations participants who may require this additional support following involvement in the conversations. Up to £1,500 would be made available to Al-Hurraya specifically for this purpose and will only be utilised if any individual takes up the offer.</p>
