<b>EXECUTIVE SUMMARY:</b>
<p>This funding sees a distribution of bleed kits to city centre businesses updating a previous initiative by Nottingham BID/VRP in 2019. Alongside the distribution of the kits will be training to ensure safe and effective use.</p> <p>The contents of the bleed kits include:</p> <ul style="list-style-type: none"> <li>• Trauma Dressing – Designed to control moderate bleeding</li> <li>• A haemostatic gauze dressing that is very effective, designed to control moderate to very severe haemorrhage</li> <li>• An innovative dressing for emergency management of penetrating chest wounds</li> <li>• SOFTT-W tourniquet</li> <li>• Nitrile Gloves – Personal protection</li> <li>• Scissors</li> <li>• Instruction Card</li> </ul> <p>The bleed kits are designed to provide an intervention ahead of the ambulance crew arriving in the event of an emergency.</p>

<b>INFORMATION IN SUPPORT OF DECISION: (eg report or business case)</b>
Nottingham BID have sought quotes for bleed kits and have undertaken a thorough audit of businesses to determine need. Training will be provided to all businesses.

<b>FINANCIAL INFORMATION</b>
The funding is revenue and is in budget. The money will purchase 60 bleed kits costing £80 each. The money is sought from the core VRP budget.
