
<b>EXECUTIVE SUMMARY:</b>
<p>The purpose of this notice is to seek approval for the purchase of 74 Skoda Octavia vehicles, 45 of which will be provided as turnkey solutions, to a value of £1,805,608.38. The vehicles will be procured through the compliant Crown Commercial Services framework 'RM6244 – Purchase of standard and specialist vehicles' under lot 4, Bluelight cars and motorcycles (emergency services)</p>
