EXECUTIVE SUMMARY:
<p>The PCC is requested to confirm her approval for the following grant awards:</p> <ul style="list-style-type: none"> Up to £16,500.00 to five local community organisations through Round 1 of the 2023/24 Make Notts Safe Community Chest Grants. <p>The entire budget will come from the 2023/24 grants and commissioning budget.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)																		
<p>In March 2023 the PCC launched the first round of her Make Notts Safe Community Chest grants scheme. The Make Notts Safe Community Chest fund aimed to provide seed corn funding for community based organisations to enable local delivery against the Commissioner’s priorities. Grants of up to £10,000 were available in exceptional circumstances with specific funding ringfenced for hate crime projects.</p> <p>Applications were invited from community organisations with all applications undergoing a robust assessment process in which all applications were assessed by a minimum of two officers from the OPCC against a RAG rated matrix. Applications were then discussed at an independent Stakeholder Panel which included senior police officers, representatives from the City and County Council as well as representatives from the VRP. The panel agreed a final list of recommendations which went to the PCC. The PCC agreed that 5 projects would be funded to a total value of £16,500.00. Brief details of the 5 grants recipients are detailed below – further information about these grants is available on the PCCs website. Please note all grant funding is subject to organisations meeting specific funding criteria.</p>
