EXECUTIVE SUMMARY:
<p>As per decision record 2023.005 and 2023.029, Home Office funding amounting to £1,021,365 has been secured for the financial years 2022/23, 2023/24 and 2024/25 to allow the PCC and partners to pilot and develop multiple programmes to increase the number of Children Affected by Domestic Abuse (CADA) in Nottinghamshire who recover from harm, and subsequently are better able to achieve their full potential.</p> <p>The previous element of therapeutic support was approved up until 31st March 2023. This decision record is to request approval for the therapeutic support to be offered between 1st April 2023, and 31st March 2025 and is detailed as per below.</p>

<p>Funding for therapeutic support had previously only been awarded for 2022/23. The PCC has recently held a grants application process to invite providers to apply for funding to provide the therapeutic element of support for the next two financial years (2023/24 and 2024/25). The applications have been reviewed and the successful providers are detailed below.</p> <p>The funding will be provided from the Home Office CADA budget.</p>
