**TITLE:** Capital Outturn Carry Forward 2022/23

### **EXECUTIVE SUMMARY:**

The capital budget for 2022/23 was £12,587k, the outturn at the end of the financial year was £6,616k resulting in an underspend of £583k and a carry forward request of £5,388k.

Carry forward is requested where it has not been possible to complete a project in the financial year in which the budget was allocated.

Supply chain issues, contractor issues and shortage of staff resources have played a major part in the delivery of the capital programme therefore carry forward of £4,695k into 2023/24 and £693k into 2024/25 is requested to support the continuation of projects through to completion.
