
<b>EXECUTIVE SUMMARY:</b>
<p>The PCC has been approached by Awsworth Parish Council to provide match funding towards a CCTV system upgrade in the local area with the overall aims of being better able to prevent crime and ASB, respond to concerns and the support and safeguard all users of the recreational site and facilities.</p> <p>The PCC is therefore requested to confirm her approval to use 2023/24 Grants and Commissioning Budget to:</p> <ul style="list-style-type: none"> <li>Award a grant of up to £3,250 to Awsworth Parish Council as match funding towards a CCTV system upgrade.</li> </ul>


<b>INFORMATION IN SUPPORT OF DECISION: (eg report or business case)</b>
<p>Awsworth Parish Council approached the PCC for match funding in relation to a full upgrade and extension of their CCTV system. The current system is over 20 years old and is an analogue system. The proposal is to fully upgrade and extend the CCTV system to a fully digital system with additional cameras. The aim being that this will help to prevent ASB and criminal damage which is currently taking place outside of the current camera locations. The Council also hopes that this will help to make the recreational area feel safe for all users.</p> <p>Site visits and quotes have been obtained to ensure that it complies with government guidance and Awsworth Parish council will be responsible for the ongoing maintenance and upkeep of the new system.</p>
