### **EXECUTIVE SUMMARY:**

The Commissioner is seeking a provider to develop, undertake and analyse surveys and focus groups.

A Request for Proposals was disseminated to seven organisations. Two bids were received and following an evaluation of these bids, SMSR Ltd is the preferred bidder. The Contract will run from 1 August 2023 to 31 March 2025.

The total value of the contract is estimated to be no more than £50,000 for the duration of the contract, including any potential call off work throughout the duration of the contract.

The PCC is therefore requested to approve the award of a contract to SMSR Ltd to develop, undertake and analyse a range of focus groups and surveys as required to help inform specific areas of work at a total cost of up to £50,000 from August 2023 to March 2025.

### **INFORMATION IN SUPPORT OF DECISION:** (eg report or business case)

A Request for Proposals including a detailed breakdown for the below areas of work was disseminated to seven organisations:

- End of project survey for Safer Streets 4
- Policing Priorities and Budget Setting Focus Groups for 2023/24 and 2024/25 and
- Pricing examples for a day rate for ad hoc survey and focus groups.

Two bids were received. Bids were scored independently by four individuals and then moderated as a group. Bids had to meet quality and financial threshold scores. SMSR Ltd was the highest scoring bidder.
