EXECUTIVE SUMMARY:

In-year transfer to reserves

Within the financial year 2022/23 the following allocations to reserves were made in-year:

- £1,000,000 in relation to additional funding received from the Home Office for the recruitment of 50 temporary additional officers was transferred to an earmarked reserve
- £62,624 to the Late-Night Levy reserve
- £55,968 to the Asset Recovery Incentivisation Scheme reserve
- £4,264 to the Traffic Safety Camera Project reserve
- £169,967 to the Grants & Commissioning reserve for the Violence Reduction Programme (VRP) use in 2023/24.

For 2022/23 the Chief Constable's revenue budget is underspent by (£2,528k). This is proposed to be allocated as follows:

- £310,000 is to be transferred into reserves in respect of revenue carry forwards
- £1,649,000 is to be transferred into the insurance reserve
- £569,000 net contribution to the general fund reserve.

For 2022/23 the OPCC revenue budget is underspent by (£2,260k). This is proposed to be allocated as follows:

- £1,500,000 is to be transferred into a newly created earmarked reserve for Sustainability
- £500,000 is to be transferred into the earmarked Grants and Commissioning reserve
- £260,000 net contribution to the general fund reserve
