EXECUTIVE SUMMARY:

In lieu of the pension remedy activity required (McCloud judgement) there needs to be a variation in the agreement to XPS for payment milestones in relation to this additional work that needs completing.

The additional cost to Nottinghamshire is £584,971 between now and 1st April 2025 and is part of the nationally agreed amounts.

There may be opportunity that this, or a proportion of this, is funded centrally but until further detail the assumption is for it to be self funded.
