EXECUTIVE SUMMARY:

Following discussion and approval from the Late Night Levy Steering Group, the Violence Reduction Partnership seek approval to utilise £9,519 from the Late Night levy budget to Cover the cost of a Safe Space resources within the City Centre.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The proposal was supported by members of the Late Night Levy Steering Group, pending formal approval from the OPCC. The resources include:

Safe Space Pledge Information Packs. 200 to be purchased which include posters, booklets and support cards. Cost: £4109

Safe Space 'supporter' window sticker. To provide venues who wish to support the Safe Space Pledge message and initiative with promotional window stickers to place within their own window. £1350

VAWG Training. To commission Equation to deliver their 'Safety of Woman at Night' training to a variety of licenced premises in Nottingham City, over a 1-year period. To deliver VAWG training, management of delivery through Eventbrite, provide qualified facilitators and written evaluation. To include the adaptation of the 'Safety of Women at Night' training. £2060

Graphic Design. To commission the Consent Coalition Graphic Designer to:

- Update all the following Safe Space resources: SSP posters, banners, stickers etc

To design the:


- Safe Space Pledge resource folder
- Safe Space Pledge social media designs for media pack
- Safe Space Pledge artwork for It's In Nottingham and partner agency websites
