<p>Further to DR 2023.048 which detailed that up to £200,000 would be allocated for Locality funding and distributed amongst the seven districts councils, this decision records seeks approval for the more detailed breakdown of the funding as shown below. The additional £11,552 will be funded utilising the Commissioner’s grants and commissioning budget.</p>

<p>Each of the seven district councils have submitted a business case to the PCC detailing their proposed spend on initiatives to help achieve the strategic goals in the Nottinghamshire Police and Crime Plan.
