EXECUTIVE SUMMARY:

The current non-domestic stalking contracts are due to terminate on the 30th September 2023. From the 1st October 2023, Nottinghamshire Women’s Aid will hold the new contract, and will be sub-contracting to Juno Women’s Aid as well as Equation, to continue to support victims of non-domestic stalking.

Funding however for Equation, to provide training and resources around non domestic stalking, will come from the PCC grants and commissioning budget. The total amount requested between October 2023 and March 2026 is £21,868.00.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

From the 1st October, Nottinghamshire Women’s Aid will hold the contract to deliver the Nottinghamshire Stalking Advocacy Service providing support to victims and survivors of non domestic stalking. The production of resources and delivery of training in relation to non DV stalking is outside of this contract and will be undertaken by Equation. Funding for this will come from the PCC grants and commissioning budget. The total amount requested between October 2023 and March 2026 is £21,868.00.
