EXECUTIVE SUMMARY:

The NNVRP seeks to secure the provision of a Community Participation and Development function within Nottinghamshire County Council Youth Service to undertake comprehensive engagement across Nottinghamshire in support of the Serious Violence Duty Implementation. The role will support the development and delivery of partnership plans to tackle serious violence across the county and achieve compliance with the Duty.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The Serious Violence Duty came into effect on 31st January 2023. The Duty requires specified authorities to work together and plan to prevent and reduce serious violence, including identifying the kinds of serious violence in the area, the causes of that violence and to prepare and implement a shared strategy for preventing and reducing serious violence in the area. (PCSC Act Ch1 Part 2).

The Community Participation and Development role will include:

- Engagement and consultation with young people and wider communities in communities of identity and geography across Nottinghamshire
- Contribution to the development and delivery of partnerships plans in response to the implementation of the Serious Violence Duty.

Costs include: staffing, venue hire and refreshments, travel costs, supplies, IT services etc.

FINANCIAL INFORMATION


£74,721 to Nottinghamshire County Council split £18,944 in 23/24 and £55,777 in 24/25, (Delivery 1 October 23 to 31 March 25).


The funding will come from the Serious Violence Duty from the Serious Violence Duty Implement Budget, funded by the Home Office. The funding is revenue and is in budget.
