| <p>Following the success of previous years' Knife Crime Events, organised by the Nottinghamshire Police Youth Outreach Team, in collaboration with the Violence Reduction Partnership, a further event is planned for 2023. This will take place in November during the national week of action on knife crime, Operation Sceptre.</p> <p>The purpose of the event is to raise awareness around knife crime, its causes and impact, as well as creating an opportunity for children and young people to engage in a range of positive activities. There will be guest speakers and performances by children and young people. The event will include information stands in which the VRP and OPCC will participate alongside agencies from across the partnership with promotion and signposting to educational resources, support and diversionary activities.</p> <p>The Knife Crime Event will provide a platform for community engagement with the police and OPCC and an opportunity for the partnership to exercise its commitment to reduce violent crime.</p> |
