EXECUTIVE SUMMARY:

Further to decision record 2023.061 detailing the Victim Services framework, the PCC is requested to approve:

- Contract variation to Remedi of up to £11,185 to develop and host the Nottinghamshire Victim CARE website
- Contract variation to Remedi of up to £11,185 to develop and host the Restorative Nottinghamshire website

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The PCC commissions Nottinghamshire Victim CARE (Cope and Recovery Empowerment) service. Previously, the offer for Restorative Justice was offered within the Nottinghamshire Victim CARE service.

As of 1 October 2023, these have been separated out as two distinct services: Nottinghamshire Victim CARE and Restorative Nottinghamshire.

As Restorative Nottinghamshire is a new service, it requires a standalone website to keep its independence from the wider Victim CARE service.

During mobilisation of the new Victim CARE and Restorative Nottinghamshire services, a security software upgrade requirement was identified on the current Victim CARE website. As the provider of the Victim CARE and Restorative Nottinghamshire Services from 1 October, Remedi has secured quotes from a sub-contracted third party to develop new sites for Notts Victim CARE and Restorative Nottinghamshire. This fits within the Victim Services Framework requirements and is a compliant and swift route to market.
