EXECUTIVE SUMMARY:
<p>Following conversations with partners, the Violence Reduction Partnership seek approval to utilise £19,800 from the Late Night levy budget to Cover the cost of a Safe Space within the City Centre.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>The proposal was supported by members of the Late Night Levy Steering Group, pending formal approval from the OPCC.</p> <p>The funding is to cover the period 1st April 2023 to 31 March 2024 and will cover the costs of a Safe Space within the City Centre. The funding will be paid to Breaking Barriers Building Bridges to use a dedicated space within Cubo Nottingham Limited. The space, in the heart of the City, includes a dedicated office space and access to training rooms 24 hours a day across the week.</p> <p>The Safe Space will be used by Breaking Barriers Building Bridges for 121 support for young people and vulnerable people for 121 and group sessions and mediation. Most recently, it was a place to offer young people solace following the fatalities in June. Additionally, other partners will have access on an as required basis.</p>
