EXECUTIVE SUMMARY:

The PCC is requested to confirm her approval to provide a further grant to Leaders Unlocked to continue to develop a Youth Independent Advisory Group for Nottinghamshire and to build on these significant achievements to grow the Youth Commission further, expand its work with Nottinghamshire Police, and scale up its reach to address key priorities for the region.

The funding for this grant would run from 1 September 2023 to 30 June 2024 at a cost of £31,800 split across two financial years.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The PCC has been grant funding Leaders Unlocked to provide a Youth Commission service since May 2015 (as detailed within decision records 2016.033, 2017.039, 2018.073, 2020.029, 2021.067 and 2022.098). The OPCC would now like to continue development of a Youth Independent Advisory Group and peer-led engagement that will support key objectives of the Nottinghamshire Make Notts Safe Plan.

The PCC recognises the additional value offered via the Leaders Unlocked national infrastructure which has led to sharing of ideas and good practice among other national Youth Commissions and the involvement of Nottinghamshire members in relevant national programmes of activity.


FINANCIAL INFORMATION
