<b>EXECUTIVE SUMMARY:</b>
By providing dedicated a Treatment Centre in Nottingham in the lead up to Christmas and New Year, St John’s Ambulance will offer support quickly and effectively to alleviate pressure on local resources. Alongside the Treatment Centre, an Emergency Ambulance is on standby to convey any seriously unwell patients to the Queen’s Medical Centre.
