EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval to uplift funding of domestic abuse prevention work in schools, currently ran by Equation in the City and the County. The project is joint commissioned with Nottinghamshire County Council who are the lead commissioner under the Inter-Authority Agreement. The financial breakdown for 2022/2023, 2023/2024 and 2024/2025 is as follows:

Nottinghamshire Office of the Police & Crime Commissioners	£150,000	£200,000	£200,000 + £100,000 city uplift	£650,000

The local authorities will undertake a compliant procurement process.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The delivery of a Domestic Abuse Prevention Programme (mixed model) for Primary, Secondary and Special Schools for Nottinghamshire from 1 April 2022 to 31 March 2025.

This will be offered across age groups and delivered in a series of programmes for cohorts that include:

- Key Stage 2: Year 5 + Year 6 pupils (GREAT programme)
- Key Stage 3: Year 7, 8 + 9 pupils (EQUATE programme)
- Specialist provision for Special Schools.
- Targeted projects for small groups of young men and women where need identified (Your Choices and Know More).

The programme also includes training for professionals (teacher twilight sessions) and provision of a professional toolkit (My Connections) for working with young people who are causing harm in their intimate or family relationships.

Expanding the healthy relationships in schools provision is part of the commitment within the commissioner's Police and Crime Plan.

Confirmation of verbal agreement is sought for 2022-3. The funding is to be awarded as already agreed through the Inter-Authority Agreement with Nottinghamshire County Council and the Partnership Agreement with the City Council.
