TITLE: Police Precept 2024-25

EXECUTIVE SUMMARY:

The purpose of this decision is to formally approve the increase to the precept in 2024-25.

The Police and Crime Panel met on the 5 February 2024 to consider the proposed precept for 2024-25. A detailed summary of the Commissioner's proposed Precept and Council Tax Requirement for 2024-25 is set out in the Panel report pack attached, see agenda item 6.

The precept increase proposed of £12.96 for a band D property was supported by the Panel. A majority of members who were present at the meeting voted in favour of the proposed increase (13 members voting in support with 1 voting against).

INFORMATION IN SUPPORT OF DECISION: (e.g., report or business case)

The government published its approach relating to Council Tax referendum principles for 2024-25 as part of its Spending Review in October 2021. In all three years 2022-23 to 2024-25 PCCs were to be allowed to increase band D bills by as much as £10. In the Provisional Grant Report in December 2023 this was increased from £10 to £13 for 2024-25.

Council Tax Proposal

The Commissioner's proposed Council Tax increase for 2024-25 is £12.96 for a Band D property. This is £282.15 for a Band D property. With this increase, Council Tax provides £4.3m more funding than in 2023-24 (excluding any increase in the tax base).

The Police and Crime Commissioner's council tax is shown in the table below.

This illustrates the impact of a £12.96, 4.8% increase. The additional cost to some 60% of Nottinghamshire council tax-payers will be 19 pence per week or less.
