<b>EXECUTIVE SUMMARY:</b>
<p>Further to decision record 2022.097, the PCC is requested to approve a final 6 month extension to the Changing Lives contract to deliver the Women-Specific Conditional Cautions Project between 1<sup>st</sup> April 2024 and 30<sup>th</sup> September 2024. This is a total funding commitment of £23,214 to be funded by 2024/25 Grants &amp; Commissioning Budget.</p> <p>This contract extension will ensure the OPCC has time to carry out market testing on Out of Court Disposals and go out to tender for future provision. This will also ensure continuity of service for vulnerable individuals.</p>


<b>INFORMATION IN SUPPORT OF DECISION: (eg report or business case)</b>	
<p>The project provides trauma informed support and diversion for vulnerable women from the point of arrest, with a Diversion Worker responsible for identifying individual support needs linked to their offending and brokering access into the relevant local services.</p> <p>By the end of the support period, the service aims to have linked each participant to longer term support in their community and the skills to know what to do should they find themselves at risk of reoffending. The project provides a crucial early point of contact for low level offending with a view to reducing entrants into the Criminal Justice system and pinpointing factors that influence offending.</p>
