1. Legislation

[Anti-social Behaviour, Crime and Policing Bill](#) - The **Anti-social Behaviour, Crime and Policing Bill** completed the commons committee stage on 16 July 2013.

[Legislation proposed to close level crossings](#)

A new procedure should be created to close level crossings, the Law Commission has proposed. In a joint [report](#), the Law Commission for England and Wales and the Scottish Law Commission call for the safety regime around level crossings to be improved.

[Licensing Act 2003: amended guidance issued under section 182](#) - Section 182 of the Licensing Act 2003 provides that the Secretary of State must issue and, from time to time, may revise guidance to licensing.

[Scrap metal laws to stop metal theft come into force](#) - Rogue traders who buy and sell scrap metal for cash face £5,000 fine under new laws designed to stamp out metal theft.

2. Policing and crime key developments

[Automatic 'early release' axed for child rapists and terrorists](#)

In a radical overhaul of sentencing, the Justice Secretary Chris Grayling today announced that criminals convicted of rape or attempted rape of a child or terrorism offences will no longer be automatically released at the half-way point of their prison sentence.

[Grayling to scrap cautions for serious offences](#)

The use of simple cautions for serious offences will be banned, justice secretary Chris Grayling has announced. The plan follows a review earlier this year and MoJ statistics which show that last year 493 cautions were issued for crimes that would have been heard at the crown court, instead of the magistrates' court, if they had gone to trial. There were 167,758 simple cautions issued to adults in 2012, according to the figures.

A new central repository will allow child care professionals to learn from serious case reviews (SCRs), the NSPCC has announced. In collaboration with the association of independent LSCB (Local Safeguarding Children Board) chairs, the NSPCC will make the reviews publicly available to increase learning.

Recent road casualty figures have shown the number of deaths involving drink driving in UK are increasing by more than 25% year-on-year, with a large amount of those being young adults. George Osborne MP, Chancellor of the Exchequer, has announced that long-term unemployed welfare claimants will have to perform 30 hours of community service a week in order to continue receiving benefit payments.

The new Help to Work scheme, which will be introduced next year, could see as many as 60,000 claimants doing Community Work Placements or being obliged to visit their Jobcentres every day ([FT](#); [Telegraph](#); [Guardian](#); [Independent](#); [Mail](#); [BBC Online](#); [City A.M.](#)).

First Social Enterprise Cities announced

Bristol and Plymouth have been awarded Social Enterprise City status, as part of a Social Enterprise Places scheme run by Social Enterprise UK.

The pilot encourages locals to buy from social enterprises, and nominations can be entered at towns@socialenterprise.org.uk.

Help to Work scheme announced by the government

The government has announced Help to Work - a new scheme designed to tackle long term unemployment. For the first time, people in long-term unemployment who are capable of work will be asked to work in return for their benefits, the Chancellor has announced.

Cash boosts for councils backing neighbourhood planning

Councils around the country can claim up to £100,000 a year to help their communities start a neighbourhood plan, with an additional £25,000 for plans that pass a successful examination.

Chief Inspector of Probation

Paul McDowell, currently Chief Executive of NACRO, has been announced as the preferred candidate to be her Majesty's Chief Inspector of Probation. The Justice Select Committee will now decide whether to proceed with the appointment.

Needle and syringe programmes

NICE guidance on needle and syringe programmes is being updated and it is expected to be published in March 2014.

New parking reform proposals to support local shops and high streets

Government ministers have announced a series of proposals for consultation to reform parking rules to help with the cost of living and support local shops. The proposals for formal consultation will be announced shortly.

Drinkaware call for evidence on binge drinking

Drinkaware is launching a review in support of the Government's Alcohol Strategy to develop

a coherent, well evidenced strategy with regard to the role that Drinkaware could play in reducing the harm from public drunkenness and its negative consequences. The consultation runs until 11th October.
