### **Criminal Justice and Courts Bill**

On 10 November the Government accepted an amendment at the Lords Third Reading of the Criminal Justice and Courts Bill to give 17 year olds detained in police custody the same rights as children aged 10-16. The Bill is expected to gain Royal Assent in the Spring of 2015.

The Home Secretary has appointed Kevin Hyland as the UK's first ever Independent Anti-Slavery Commissioner. The newly-created role will see him spearhead the UK's fight against modern slavery, with a concerted focus on strengthening law enforcement efforts in the UK and internationally and helping to ensure that public authorities identify and support slavery victims effectively.

Local authorities and service providers are able to apply for capital funding to support recovery-focused projects, following a similar process earlier this year.

### [Government should introduce five-year spending plans – Lord O'Donnell](#)

The government should introduce five-year spending plans to match the length of fixed-term parliaments, and institute independent assessment of its infrastructure strategies, according

to former cabinet secretary Lord (Gus) O'Donnell. In a recent [speech to the Royal Statistical Society](#) on 'evidence-based policy making in the era of big data', Lord O'Donnell said: "We now live in a world of five year fixed-term parliaments but nobody has followed up to change our procedures to fit with this new world. We could have a mid-term course correction exercise to refresh the programmes and adjust course depending on how far the public finances had deviated from the projected flight path."

## **[More councils merge functions and power as 'combined authorities'](#)**

Council leaders in the West Midlands are the latest to plan a combined authority for their region, which would act as a "lynchpin for the national economic recovery" and create a "Midlands Powerhouse". Greater Manchester's combined authority working since 2011 is widely believed to have contributed to its recent economic and infrastructure successes, and other areas are seeking to emulate the idea. Three further combined authorities were established on 1 April 2014, in the city-regions of Leeds, Sheffield and Liverpool, and the North East Combined Authority was set up later that month.

## **[HWBs should not take on full responsibilities for health budgets, say CCGs](#)**

Health and wellbeing boards (HWBs), run by councils and health representatives, have a unique role in joining up health and care commissioning – but are not the appropriate bodies to take on the full responsibilities for health budgets. The point was raised in a new report '[A Shared Agenda – creating an equal partnership with CCGs in health and wellbeing boards](#)' where it is argued that the clinical expertise that CCGs bring play a "critical" and "central" role on HWBs, and one that is vital if integrating health and social care across the NHS and local government is going to become a reality.

## **[FCA finds small firms need to manage financial crime risks more effectively](#)**

The Financial Conduct Authority (FCA) has found that many small banks and commercial insurance intermediaries fail to effectively manage financial crime risk. The two reviews published today follow related work by the FCA's predecessor on banks in 2011 and intermediaries in 2010.

Council leaders in Derry have joined forces to condemn death threats against the city's community safety wardens. Earlier this week it emerged dissident republicans had made the threats against 11 staff from the wardens scheme, which deals with low level antisocial behaviour.

## **Better Care Fund plans branded 'a shambles' by MPs**

Plans to save money by merging health and social care have been blasted as 'a shambles' after it was revealed they have delivered less than a third of the £1bn originally estimated. Chair of the Public Accounts Committee, Margaret Hodge, said she was 'dismayed' by delays and changes to the Better Care Fund, which had weakened its credibility with local bodies.

## **Maude: £2bn saved in quango cull**

Reforming and abolishing public bodies has saved more than £2bn since 2010, according to minister for the cabinet office Francis Maude. He says savings have been achieved in a review of more than 900 public bodies in the last four years in which at least 185 have been abolished and 165 merged into fewer than 70, reducing the overall number by a third.

## **Ombudsman case highlights need for same sex carers**

Care providers have been urged to ensure vulnerable clients have access to same sex carers following a case in Warwickshire where a council failed to do so despite it being stipulated in a support plan.

## **Report: north of England missing out on infrastructure funding**

The north of England is being hampered by a lack of investment in infrastructure despite contributing more to the UK economy than Scotland, Wales and Northern Ireland combined, a report has claimed. The think tank IPPR North argued Government spending is 'highly skewed' towards London and Scotland, particularly when it comes to key areas like transport investment.

## **Overhaul business rates to help small firms and save high streets – LGA**

Popular independent traders, family firms and businesses which use local suppliers could pay less in business rates under reforms proposed by councils which could help save England's high streets.

## **Council demands independent inquiry into alleged attacks by Libyan cadets**

Cambridge City Council has demanded a full independent inquiry into circumstances surrounding recent alleged sexual attacks involving Libyan cadet soldiers.

## **Cameron announces £15bn 'roads revolution'**

Britain's worst traffic hotspots will be targeted in a £15bn roads makeover to be announced by prime minister David Cameron. Hundreds of extra lane miles will be created on motorways and trunk roads as part of a 'roads revolution' to speed up journey times, he told the annual conference of the Confederation of British Industry's (CBI).

The Independent Police Complaints Commission is investigating Surrey Police's decision to return confiscated licensed guns to a man who went on to kill two women.

#### West Midlands Police inspected on child protection

HM Inspectorate of Constabulary (HMIC) has today published an inspection report into the child protection work carried out by West Midlands Police, following an inspection in June 2014. This is part of a rolling programme of child protection inspections of all police forces in England and Wales.

HMIC has published the latest value for money profiles which provide comparative data on a wide range of policing activities.
