1. Legislation

Data Retention and Investigatory Powers Act 2014

This Act received Royal Assent on 18 July and relates to EC Directive 2006/24/EC, the retention of communications data and the authorisation of the interception of telecommunications.

Social Action, Responsibility and Heroism Bill

This Government Bill was presented to Parliament on **12 June 2014**. The Bill had its second reading debate on **21 July 2014**. This Bill has now been committed to a Public Bill Committee who will scrutinise the Bill line by line. The Public Bill Committee shall meet on a date yet to be announced. The Public Bill Committee is expected to report to the House of Commons by **14 October 2014**.

Serious Crime Bill

This Bill was presented to Parliament on **5 June 2014**. Line by line examination of the Bill took place during the third day of committee stage on **15 July 2014**. Amendments discussed covered clauses 62, 63, 65, 67, 69 and 70 of the Bill. Report stage – further line by line examination of the Bill will begin on **14 October 2014**.

Criminal Justice and Courts Bill

This Government Bill completed its passage through the House of Commons on **12 May 2014**. The Bill was carried over to the 2014-2015 parliamentary session and had its first reading in the House of Lords on **18 June 2014**. Line by line examination of the Bill took place during committee stage on **23 July**. Amendments discussed covered clauses 29, 36, 38, 39 and 42 to 48 of the Bill. Committee stage continued on **28 July** when further amendments were discussed. Report stage – further line by line examination of the Bill is scheduled for **20 October 2014**.

Ministry of Justice served with £180,000 penalty following encryption errors

The Ministry of Justice received a monetary penalty of £180,000 following a serious breach of the Data Protection Act. The breach was caused by the loss of an unencrypted hard drive at HMP Erlestoke in Wiltshire in May last year. The drive contained sensitive information relating to 2,935 prisoners.

Penalty clause of up to £400m if probation contracts cancelled

The next government could face a penalty clause of £300m-£400m if it tries to cancel the controversial probation privatisation contracts. The Labour Party has pledged to scrap the Ministry of Justice (MoJ) contracts that outsource probation services should they win the next general election.

Birmingham to cut another 6,000 jobs

Up to 6,000 council jobs are to be axed in Birmingham over the next four years, as the leader of the council announces its workforce will be dramatically reduced.
