Home Office circular 021/2015 on police misconduct published

Home Office circular 021/2015: changes to Home Office guidance on police misconduct, unsatisfactory performance and attendance management procedures was published on 11 June. It includes updated Home Office guidance on police misconduct and unsatisfactory performance procedures.

Ofsted and police service express concern over child sexual exploitation

Ineffective processes for sharing information are still hampering action on child sexual exploitation, Ofsted's chief inspector has said.

Karen Bradley's How Safe Are Our Children conference speech

Minister for preventing Abuse and Exploitation, Karen Bradley, gave a keynote Speech yesterday at the National Society of Prevention of Cruelty to Children (NSPCC) on 'how safe are our children?'. In her speech, Mrs Bradley refers to the ongoing work on preventing child abuse and providing support for victims by enhancing the services available to them under the Victim's Code and enshrining victims' rights in primary legislation. She referred to the prioritisation of child sexual abuse as a national threat in the Strategic Policing Requirement, the work of the National Policing Lead, Chief Constable Simon Bailey, and the National Crime Agency. Mrs Bradley stated the Government is launching a whistleblowing hotline for professionals later this year and may introduce mandatory reporting of child abuse.

Right here right now: Care Quality Commission report published

This report by the Care Quality Commission and reviews the quality, safety and effectiveness of care provided to those experiencing a mental health crisis. The Care Quality Commission sought to understand whether people were being offered the right care, at the right time, whether they were being given the information they needed, as well as what they felt about the attitudes of those providing help, care and support. Their findings show clear variations in the help, care and support available to people in crisis and that a person's experience depends on where they live and with which part of the system they come into contact.

College of Policing's response to the Right here right now report

In its response to the above report, the College of Policing highlighted the report's praise for the police service in dealing with people suffering from a mental health crisis.

Chief signals imminent departure

Cleveland Chief Constable Jacqui Cheer has announced that she's going to retire from policing in 2016 after 32 years' service.

3. Developments and reports

New effort to combat extremism

A regional website aimed at 'providing support and advice' to combat Islamic radicalisation has been launched. According to the Eastern Region Counter Terrorism Intelligence Unit, <u>'Let's Talk About It'</u> provides information in line with the government's Prevent strategy, as well as a range of supporting material. The site - which the CTIU designed - also provides links to partner agencies to help communities spot the signs of radicalisation at an early stage.

Police cadets present solutions to stamp out community issues

A group of aspiring police officers have put forward their solutions to tackle a host of serious community issues as part of a bespoke University of Derby cadets training course. Thirty-five police cadets have spent the last 12 months working with community groups and authorities to come up with projects to stamp out domestic burglary, dog fouling, the theft of Asian gold, anti-social behaviour, bike thefts and drug misuse.

3 sex offences an hour and rising, NPCC CP lead suggests

After a <u>new report from the NSPCC</u> revealed that three sex offences against children every hour in the UK last year, the National Police lead on child protection said he was "certain" the figures would continue to rise. Police record 8,500 more child sex offences in a year. The number of police-recorded sexual offences against children in England and Wales has risen by a third over the past year recorded. Figures compiled by the NSPCC in their <u>annual How</u> <u>Safe? report</u> showed 85 offences were recorded by police every day, with significant rises in Scotland and Northern Ireland also.

Children referred to social services reaches 'all-time high'

The number of children referred to social services in England last year reached its highest total since records began.

Football officer thanks England fans

The national lead on football policing has commended fans for contributing to an 'incident free weekend' following England's recent 0-0 draw with Ireland.

Met to get 20,000 body cameras for officers

Plans to equip all Met Police officers with cameras on their uniforms have been announced by the Mayor of London.

Public sector most 'at risk' of cyber-attack

Public sector organisations are the number one target for malware attacks in the UK, according to the latest survey. Nearly 40% of malware attacks - surreptitious downloading of software to disrupt computer operations, gather sensitive information or gain access to private systems - were against public sector organisations, NTT Com Security, says in its 2015 Global Threat Intelligence Report.

Councils must heed Armed Forces Covenant, ombudsman warns

The local government ombudsman Dr Jane Martin has warned that local authorities which have signed the Armed Forces Covenant must make sure military personnel and their families are not disadvantaged.

The Crown Commercial Service (CCS) Vehicle Purchase framework aligns with the Social Value Act.

Local government funding system 'inconsistent and unstable'

The current funding system for local government is "inconsistent, unstable and uncertain", according to senior finance officers from 36 local authorities.

One in three councils cut funding to Healthwatch groups

Almost a third of local authorities are cutting the budgets of local Healthwatch groups, some by up to 50%, the health and care watchdog has warned.

Unemployment drops by 43,000

Comparing the estimates for February to April 2015 with those for the 3 months to January 2015, employment continued to rise and unemployment continued to fall. These changes maintain the general direction of movement since late 2011 to early 2012.

North east suffers most from job cuts, figures show

Cuts in public sector jobs have hit some regions harder than others, according to the latest figures.

Council funding cuts could 'mute' patients, health watchdog warns

Health service consumers' watchdog Healthwatch is demanding to know how local authorities which have cut its funding plan to continue their work.

Council chiefs warn over impact of proposed mergers

Council leaders have warned the proposed restructure of local government in Wales – which will see 22 local authorities cut down to eight or nine – will cause 'disruption and distraction' in the sector.

Core Cities UK hold 'positive' devolution talks with Greg Clark

The Core Cities UK cabinet have had a "positive" meeting on devolution with the new secretary of state for communities and local government today. The leaders and mayors of the UK's 10 Core Cities met with Greg Clark in London, and PSE has been told that the talks have given a "real boost" to the urban policy on devolution.

Real wage growth highest since 2007

Official figures show that the annual real wage growth is at 2.7 per cent – the highest it has been since 2007.

Council initiative launched to strengthen communities

North Yorkshire County Council has launched a new initiative aimed at supporting and strengthening communities.

South-east councils make joint devolution bid

Three county councils in the south east have written to the communities secretary asking to begin negotiations for devolved powers.

Local government in 'perfect storm' of cuts says Unison

Local government is in the eye of a "perfect storm" of cuts and privatisation, according to the largest public sector union.

Redundant public sector workers urged to be more mobile in new report

Former public sector staff have been warned to find new jobs in the private sector quickly to avoid being unemployed for too long, in a briefing paper from the Institute for Fiscal Studies (IFS).

Councils successfully getting high-risk people to have a free health check

More people are having a free NHS health check since local authorities took over the responsibility for delivering them, new figures have revealed.

Think tank makes call for new local housing bodies

Local housing partnerships are the 'only way' to tackle the lack of affordable housing in this country, according to a report from think tank ResPublica.

House building could 'jam' roads unless public transport gets boost

House building projects risk descending the road network into gridlock if public transport planning doesn't significantly improve, a report has warned.

Housing complaints rise to 430k, charity reveals

Over 430,000 housing complaints were made to Citizens Advice last year, as the charity urged councils to get involved in a 'broad-ranging' residential debate.

Public supports right to complain direct to Ombudsman

The public would like the ability to complain direct to the Ombudsman, a new survey has shown.

Two thirds of people not complaining about unsatisfactory public service

Fears about unsatisfactory public services are going 'unheard or unaddressed' as research suggests two thirds of users don't complain despite being unhappy. NAO found that 25% of people using social care services faced problems such as poor quality of service, with 10% of childcare users not being happy with the service provided.

80% of public sector ombudsman complaints are about NHS

Nearly 80% of all complaints to the Parliamentary and Health Service Ombudsman (PHSO) are about the NHS in England, a new report has revealed. The other 20% of complaints the service receives concern government departments and their agencies, such as the Border Force, DVLA and HM Courts and Tribunals Service.

How to run a country: health and social care

Reform is publishing recommendations for the 2015 Spending Review. The analysis will be published on each of the main areas of public spending. The full report will be published on Tuesday 23 June.

Southwark propose changes to adult social care payments

Southwark Council are considering ways in which to change how adult social care in the region is paid for. Residents who receive funding towards their social care could soon be asked to contribute towards their care following the new proposals.

Machine-to-Machine technologies could save councils £400m a year says research

Councils are failing to utilise Machine-to-Machine (M2M) technologies, missing out on over £400m a year in potential savings, according to new research.

Warning business rate reform should not 'undercut' council funding

The Government has been warned not to use the reform of business rates as an 'excuse' to reduce funding for local authorities.

Osborne reveals £230m spending cut for DCLG

George Osborne has revealed £230m will be cut from the Department for Communities and Local Government's (DCLG) spending budget this year, as part of £3bn saving measures.

Not enough private sector jobs for upcoming public sector cuts

A report from the Institute for Fiscal Studies (IFS) found that the public workforce is set to fall by up to 800,000 by 2018-19, compared to a drop of 375,000 from 2010 to 2014.

'To let' signs are being banned in a part of Liverpool where large numbers of students live in private rented accommodation.

County signs £400m deal with Kier over empty buildings

Staffordshire County Council and the local police commissioner have signed a £400m deal with firm Kier Group to unlock the value of empty and underused buildings.

Government leaving £15bn payment by results schemes 'unmonitored', says watchdog

The Government has no idea whether its payment-by-results schemes are providing value for money, according to its own spending watchdog.

Welsh councils could save £151m on admin finds report

Councils in Wales could save £151m a year in administrative costs if they transformed back office services in line with English authorities, a new report has concluded.

Reform of Welsh councils unveiled

Plans to cut the number of local authorities in Wales to eight or nine have been unveiled by the Welsh Government.

DH underestimated cost of Care Act to councils, warns NAO

The National Audit Office (NAO) has warned the Department of Health that it "may have underestimated the cost to local authorities" in introducing the first phase of the Care Act.

NHS can save up to £5bn a year through efficiencies – Lord Carter review
