Coming into force: 21 June 2015. Extends to: England and Wales and Northern Ireland Of interest to: Local Authorities, Finance Dept. Chief Executives, PCCs, and Chief Constables

# National Audit Office report: Financial sustainability of police forces in England and Wales

While police forces in England and Wales have successfully reduced costs since 2011, they do not have a clear understanding of the demands placed upon them or of the factors that affect their costs. The Home Office also needs to be better informed to make sure forces are providing value for money.

# NPCC response to NAO report into the financial sustainability of police forces in England and Wales

National Police Chiefs' Council Vice Chair, Assistant Commissioner Martin Hewitt said: "Forces have risen to the challenge of austerity making £2.53bn worth of savings and losing 36,672 officers and staff in the process. We have kept up a good service to the public but, with diminished resources and a major shift in demand, chief constables have had to make tough decisions about which issues are a priority for their force.

# Legal-high ban to bring new council powers

A new 'blanket ban' on 'legal highs' will offer councils and police more powers to tackle psychoactive substances, the government has said.

Further to last week's additional systematic reviews the College of Policing have announced two further interventions now listed on the <u>What Works Crime Reduction Toolkit</u>. These new interventions are:

- Firearm Laws This summarises the findings of two systematic reviews on firearm laws and their effect on reducing crime.
- <u>Educational interventions to prevent relationship violence in young people</u> This review focuses on educational interventions to prevent violence in adolescents and young adults specifically in the context of relationships and dating violence.

# Equality and Human Rights Commission to support the police with new stop and search training

The Equality and Human Rights Commission (EHRC) is working with the College of Policing to develop a new stop and search training programme for officers. The training will assist police officers in their statutory duties to promote and respect human rights and equality laws 'with a particular focus on reducing unconscious bias and discrimination, particularly against young black and Asian men.'

# Police could be taken off the beat to cope with the 'overwhelming' 70% increase in rape cases, Scotland Yard chief warns

Police could be taken off the beat to cope with the 'overwhelming' increase in rape cases over the last decade, Scotland Yard chief Bernard Hogan Howe warned today. The Metropolitan Police Commissioner said detectives were suffering 'burn out' and warned 'something will have to give' without more resources

#### National Security Council discuss new Counter-Extremism Bill

On the **13 May 2015** the first meeting of the new National Security Council (NSC), chaired by the Prime Minister, was held. The main area of discussion regarded a new Counter-Extremism Bill. This is in response to the report published by the Prime Minister's Extremism Taskforce in December 2013.

The revised framework document replaces the first framework document which was signed by the Home Secretary and the Director General of the National Crime Agency (NCA) on 15 October 2013.

# Safety in Custody Statistics England and Wales: Deaths in prison custody to March 2015. Assaults and Self-harm to December 2014

The Ministry of Justice has published Safety in Custody statistics which cover deaths, selfharm and assaults in prison custody in England and Wales. This publication updates statistics on assaults and self-harm up to December 2014 and statistics on deaths in prison custody up to March 2015.

More councils could be forced to merge or outsource their adoption functions to speed up the placement process. The government says the powers in the new Education and Adoption Bill "would only be used if councils failed to take action quickly enough".

#### ICO report - How do police forces handle personal data?

The ICO has published an overview of how police forces in the UK handle personal data, based on audits and follow up reviews. Designed to help organisations in the criminal justice sector improve how they handle personal information, the report singles out recommendations from audits that haven't been fully addressed.

#### ICO needs 'more muscle' over council data breaches

Calls have been raised for stronger central powers over council data breaches, after an investigation revealed 129 leaks were reported last year.

#### Children's apps and privacy to be scrutinised in ICO review

The <u>ICO is reviewing 50 websites and apps</u> used by children as part of an international project. The research will look at privacy concerns around the type of personal information these services collect. Along with this information, they are looking at the explanation for collecting data and what parental permission is sought. The websites and apps will include those specifically targeted at children, as well as those frequently used by children. The same approach will be taken by 28 other privacy enforcement authorities from around the world, with a view to combining the results and sharing the trends in the autumn. The work is coordinated by the Global Privacy Enforcement Network, and follows previous reports on website privacy policies, and how apps collect personal data.

#### Tens of thousands sign petition against council 'criminalising' homelessness

Over 65,000 people have signed a petition in a bid to stop Hackney Council 'criminalising' homelessness with a new Public Space Protection Order (PSPO).

#### Social care cuts branded 'absurd' by council directors

Town hall chiefs are warning that councils are running out of efficiency savings - which have protected frontline services so far - leading to fears over the future of social care.

#### Poll reveals digital 'red tape' restricting innovation in public sector

IT leaders have called for an 'update' to digital thinking in the public sector, while highlighting difficulties with 'red tape' and cost.

The National Audit Office (NAO) has called for the Department for Work & Pensions (DWP) to use the "hard lessons" it learned from implementing its recent programme of welfare reforms to improve how it manages change and anticipates risk.

#### Teens in foster care moved too often

Teenagers in foster care are being moved to new homes too often, according to new research. A survey from The Fostering Network found that two in five (40%) of fostered teenagers are already living with their third foster family since coming into care.

#### Kerslake to chair Centre for Public Scrutiny

Lord Bob Kerslake, who rose from being CEO at two local authorities to become head of the civil service and permanent secretary to the Department of Communities and Local Government, is to take up the position of chair at the Centre for Public Scrutiny.
