1. POLICY AND PRACTICE

Autumn Budget 2017 – 22nd November 2017

The Chancellor, Philip Hammond's budget announcement makes no specific reference to policing, crime or criminal justice funding, but sets out government spending plans in the following areas:-

- £3 billion extra funding over the next two years to prepare for Brexit
- £6.3 bn new funding for the NHS to improve buildings and care (£3.5 bn) and A&E performance (£2.8 bn)
- £15.3 bn extra funding for house building over the next 5 years to establish 300,000 new homes a year
- Universal Credit claimants will be able to access a month's worth of support within 5 days from Jan 2018
- Business rates will switch to being increased by the CPI from April 2018 - 2 years earlier than planned
- Government departments will no longer have to reduce spending by £1.1 billion in 2019/20

Cyber Discovery training programme launched – 14th November 2017

Secretary of State for Digital, Culture, Media and Sport invites young people aged 14 to 18 to test their online skills in order to identify those with the potential of playing a role in the nation's cyber security as part of the £20m Cyber Discovery programme. Participants have until early January 2018 to take the assessment and will find out mid-January if they have been shortlisted to take a part in the first pilot year of the programme.

IPS drugs or alcohol dependency trial areas announced – 21st November 2017

Public Health England announces the 7 local authority areas selected to take part in a randomised controlled trial of individual placement and support (IPS) for people in or dependent on either drugs or alcohol in community treatment services. The local authority areas comprise Birmingham, Blackpool, Brighton and Hove, Derbyshire, Haringey, Sheffield and Staffordshire.

Police chief officer pay and remuneration measures announced – 17th November 2017

The Home Office and police set out a package of measures to increase transparency around chief officer employment which includes a standardised 35 days annual leave policy to be implemented following agreement between police leaders, introduction of a police-led system to scrutinise employment once chief officers leave their force and publication of a snapshot study of police chiefs' pay packages from 2015/16.

ACT for Youth: RUN HIDE TELL – 14th November 2017

Counter Terrorism Policing (CTP) publish terrorism safety advice for schools and youth organisations. The material includes an animated film aimed at 11 to 16 year olds designed to teach people how to react if caught up in an a gun or knife terror attack and what to do if they see suspicious behaviour or items.

2. RESEARCH, DEVELOPMENT AND STATISTICS

Domestic abuse in England and Wales to March 2017 – Published 23rd November 2017

ONS publish compilation of statistics relating to the prevalence and response to domestic abuse. Estimates based on the Crime Survey for England and Wales indicate that there were in the region of 1.9 million adult victims of domestic abuse in 2017/16 (1.2 million women, 713,000 men), a figure which has been in gradual long-term decline (-7%) since 2012. Police recorded 488,049 domestic abuse related crimes in 2016/17, which while marking a 16% increase on the previous year, has been significantly affected by improvements in crime recording practices. There were 46 arrests per 100 domestic abuse-related crimes in the year ending June 2017. A decision to charge was made for 72% of domestic abuse-related cases referred to the CPS by the police, and of those that proceeded to court, convictions were secured for 76% of domestic abuse-related prosecutions. There were 305 refuge services operating in England and Wales in 2017 and a total of 83,136 high-risk cases were discussed at multi-agency risk assessment conferences. Football-related arrests and banning order statistics: 2016 to 2017 – Published 23rd November 2017

1,929 football banning orders were in force as of August 2017, marking a decrease of 7% (-156) compared to August 2016 and continuing the steady reduction seen since November 2011 (3,174). Supporters of Championship clubs continue to account for the largest proportion of banning orders (32%). The data also highlights reduction in football-related arrests (1,638) in 2016-17 of 14% (-257) on the previous year and 47% on the 2010-11 season. Criminal justice system statistics to June 2017 – published 16th November 2017

Ministry of Justice statistics show continuing (-7%) reduction in the number of individuals being dealt with by the criminal justice system over the last year with the figure reaching a record low of 1.69m. The number receiving out of court disposals (263,200) has fallen by 15%, while the number prosecuted in the magistrates' courts has fallen by 5% to 1.43 million. The overall conviction ratio has increased from 84% to 86%. The average custodial sentence length (19.5 months) has continued to increase steadily since 2007 (15.3 months)

3. AUDITS AND INSPECTIONS

[HMICFRS 2017 Value for Money Profiles](#) – Published 16th November 2017

Individual force level profiles published providing comparative data on a wide range of policing activities. It is important to note that the profiles highlight what these differences are, but not why they exist. Forces and police and crime commissioners are expected to review the profiles help inform their strategic plans

[HMICFRS Hate Crime Scoping Study](#) – Published 23rd November 2017

HMICFRS publishes a review of existing knowledge of the police role in responding to hate crime and proposes priority areas of focus for HMICFRS' forthcoming inspection. These include exploration of whether:

- Forces have effective strategies in place to deal with hate crime in order to protect victims and communities;
- There are effective national and local partnership arrangements to improve reporting and recording;
- Police understand and respond to the needs of specific communities, incl. through innovative approaches;
- Police refer and encourage victims of hate crime to access appropriate support from local partner agencies;
- Police identify and assess risks to victims and communities and effectively identify and record hate crimes;
- Training and awareness provision for staff dealing with hate crime cases is effective;
- There has been an effective police response to the government's [hate crime action plan](#);
- Victims receive appropriate care and support from partner agencies.

[Children in Custody 2016/17](#) – Published 22nd November 2017

Annual HMI Probation analysis of 12–18 year olds' experiences in secure training centres (STCs) and young offender institutions (YOIs) highlights that there has been no significant change in the in profile of children in since 2015/16, with 48%-49% being from a black or other minority ethnic background, 12%-22% identifying as Muslim and 7-10% being from a Gypsy, Romany or Traveller background. Of those surveyed in STCs:-

- 22% of children had felt unsafe at some point since arriving and 6% felt unsafe at time of inspection
- 25% of children reported being victimised by other children by being shouted at through windows
- 67% of children reported having a key worker on the unit, a figure which has fallen from 89% in the last year
- Children were significantly less likely to say that their key worker helped them (74%) than last year (90%)

In relation to boys surveyed in YOIs during 2016–17, the report highlights that:

- 39% had felt unsafe at some point, having fallen from 46%, and 16% felt unsafe at time of inspection
- The proportion of boys who said they could have a shower every day fell significantly from 88% to 71%
- The proportion of boys who could use the phone every day had fallen from 80% to 68%
- The proportion saying that their caseworker helped them prepare for release increased from 41% to 49%
- The proportion saying that it was easy to see health professionals has increased significantly

Prisons and Probation Ombudsman (PPO) bulletin highlights weakness of drug testing regimes in Approved Premises for people released from prison or on bail or court orders and the need to improve information sharing and welfare checks. The report also notes that the implications of New Psychoactive Substances for the Approved Premises estate are not yet fully understood or addressed by the National Probation Service. Recommendations include tests for all suspected drugs, and opiates in particular, if the resident is a previous user for all who are at high risk of substance misuse. The report also recommends routine and targeted room searches by staff in APs, greater information sharing among appropriate agencies and provision of advice and information on the dangers of using NPS.

- Encouraging departments to put forward innovations that could improve outcomes at no extra cost

The Bill to modernise and make data protection laws fit for the digital age by empowering people to take control of their data; supporting UK businesses and organisations through change and ensuring that the UK is prepared for the future after leaving the EU. The Bill will: update regimes for data processing by law enforcement agencies; introduce a new Digital Charter to ensure that the UK is “the safest place to be online”; make it simpler to withdraw consent for the use of personal data; allow people to ask for their personal data held by companies to be erased; require ‘explicit’ consent to be necessary for processing sensitive personal data; expand the definition of ‘personal data’ to include IP addresses, internet cookies and DNA and ensure an effective regulatory framework is in place. New criminal offences will be created to deter organisations from intentionally or recklessly enabling someone to be identified from anonymised data [Government fact sheets](#)

Policing Resources Bill - Lords 2nd reading - TBC

Private Members' Bill to make provision for ensuring that police forces in England and Wales have sufficient resources to deliver police services. Proposes the appointment of an independent body to report annually on adequacy of police grant funding. Places duty on Secretary of State to ensure grant recipients have sufficient resources to prevent crime, bring offenders to justice, keep the Queen's Peace and protect, help and reassure the community. Also places duty on Secretary of State to consider PCC police and crime plans, latest adequacy of funding report and the need for contingency funding for police forces to deal with exceptional major incidents

Victims of Crime (Rights, Entitlements, Notification of CSA) Bill – Lords 2nd reading – TBC

Private Members' Bill to make provision for specifying new statutory rights and entitlements for victims of crime under the Victims Code of Practice; require PCCs to assess victims services; increase duties of the Victims and Witnesses Commissioner; grant victims the right to request a review of a decision not to prosecute; establish reviews in homicides where no criminal charge has been made; create an obligation on professions to notify cases of possible victims of child sexual abuse.

Criminal Records Bill - Lords 2nd reading - TBC

Private Members' Bill to amend the length of time for which an individual may have a criminal record under the Rehabilitation of Offenders Act 1974

Children Act 1989 (Amendment) (FGM) Bill – Lords 2nd reading - TBC

Private Members' Bill to state that proceedings under Section 5A of, and Schedule 2 to, the Female Genital Mutilation Act 2003 are family proceedings

Anonymity (Arrested Persons) Bill - Lords 2nd reading – TBC

Private Members' Bill to prohibit the publication of certain personal information until an arrested person has been charged with an offence / set out circumstances where such information can be published

Road Traffic Offenders (Surrender Driving Licences) Bill - Lords 2nd reading - TBC

Private Members' Bill to make provision about the provision and surrender of driving licences or certificates in relation to certain offences; make provision in relation to identifying persons in connection with FPNs etc.

Modern Slavery (Transparency in Supply Chains) Bill – Lords 2nd reading – TBC

Private Members' Bill to make further provision for transparency in supply chains in respect of slavery and human trafficking

Bills announced in the Queen's Speech – 21st July 2017

- **Domestic Violence and Abuse Bill** to ensure victims have the confidence to come forward and report their experiences. The Bill includes proposals to establish a Domestic Violence Abuse Commissioner to hold the justice system to account in tackling domestic abuse, define domestic abuse in law, create new domestic abuse civil prevention and protection order regime, ensure that sentencing of abusive behaviour involving children reflects the life-long impact that this abuse can have, [ratify the Istanbul Convention](#) to allow certain offences committed by British citizens anywhere in the world to be prosecuted in UK courts and to make it easier for domestic abuse survivors to [register to vote anonymously](#)
- **Courts Bill** to modernise and improve the efficiency and accessibility of the courts system. The Bill will include provisions to end the direct cross examination of domestic abuse victims by alleged perpetrators in the family courts, enable more victims to participate in trials through virtual hearings and enable those charged with some less serious criminal offences to opt to plead guilty, accept a conviction and pay a statutory fixed penalty online in order to free up court time for more serious cases
